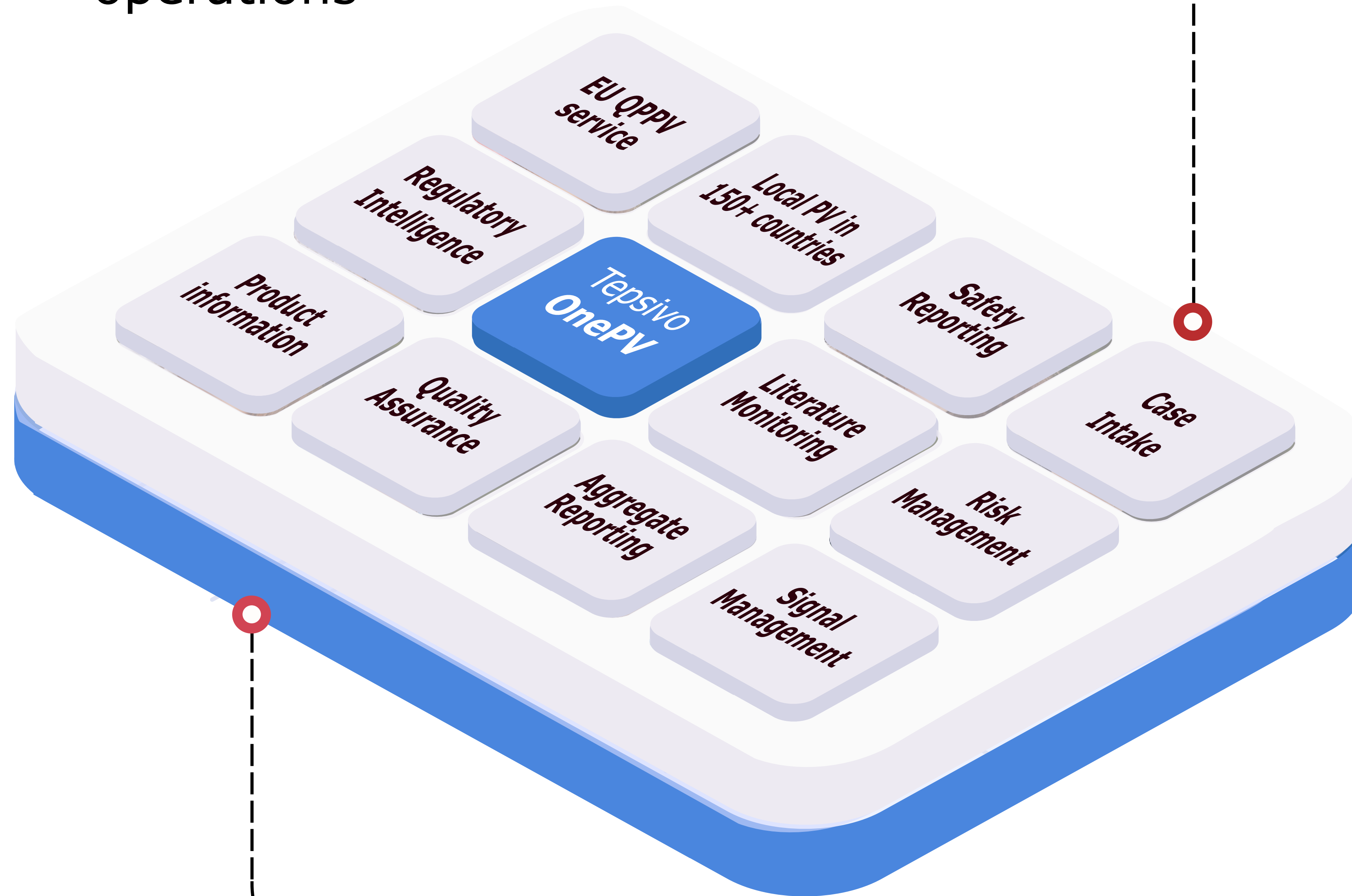

This is because it provides a single, central base — a true pharmacovigilance platform — for all your PV processes.

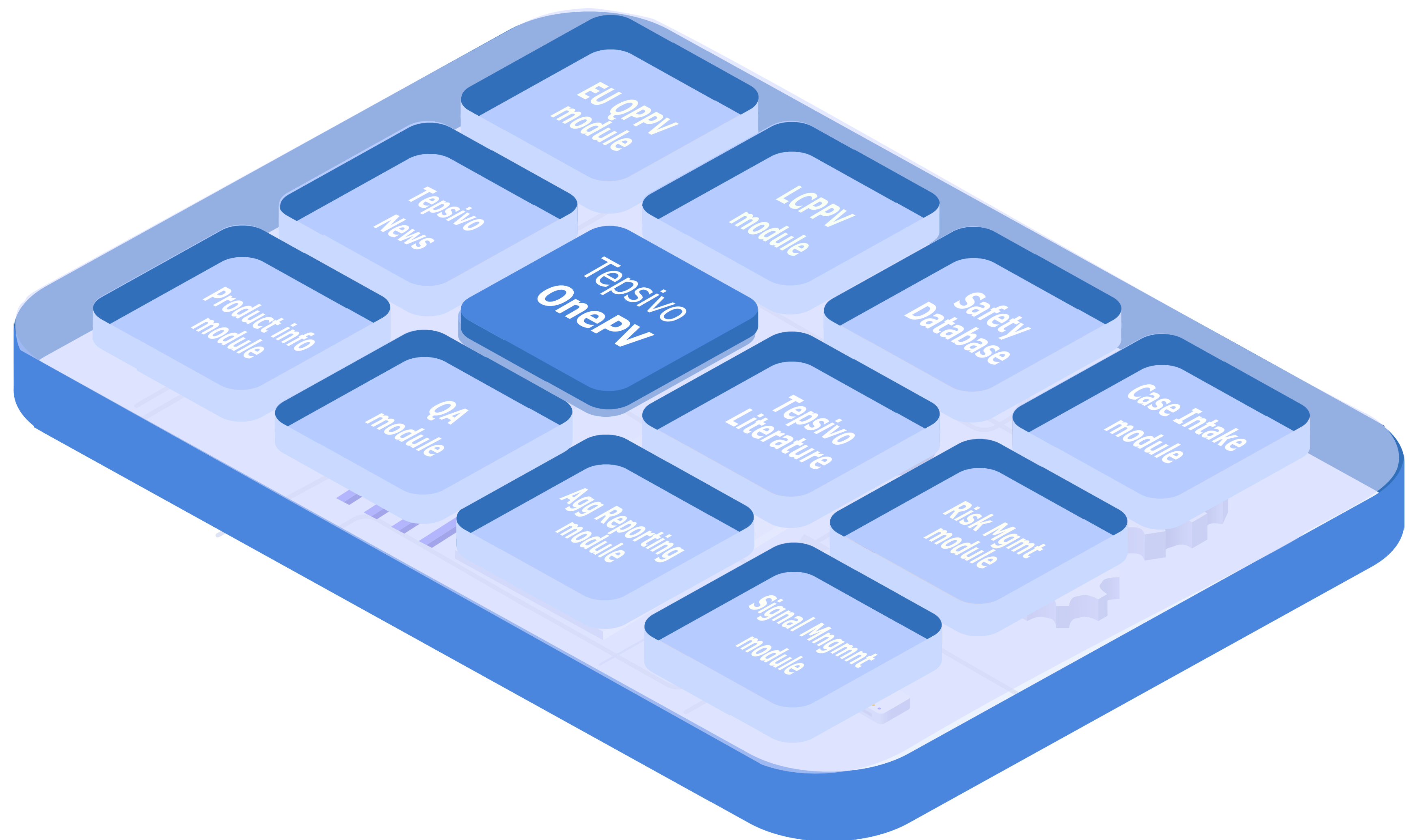
What is important here is that it is not a set of individual apps from different software providers (held together by duct tape), but a fully in-house developed and natively interconnected system.

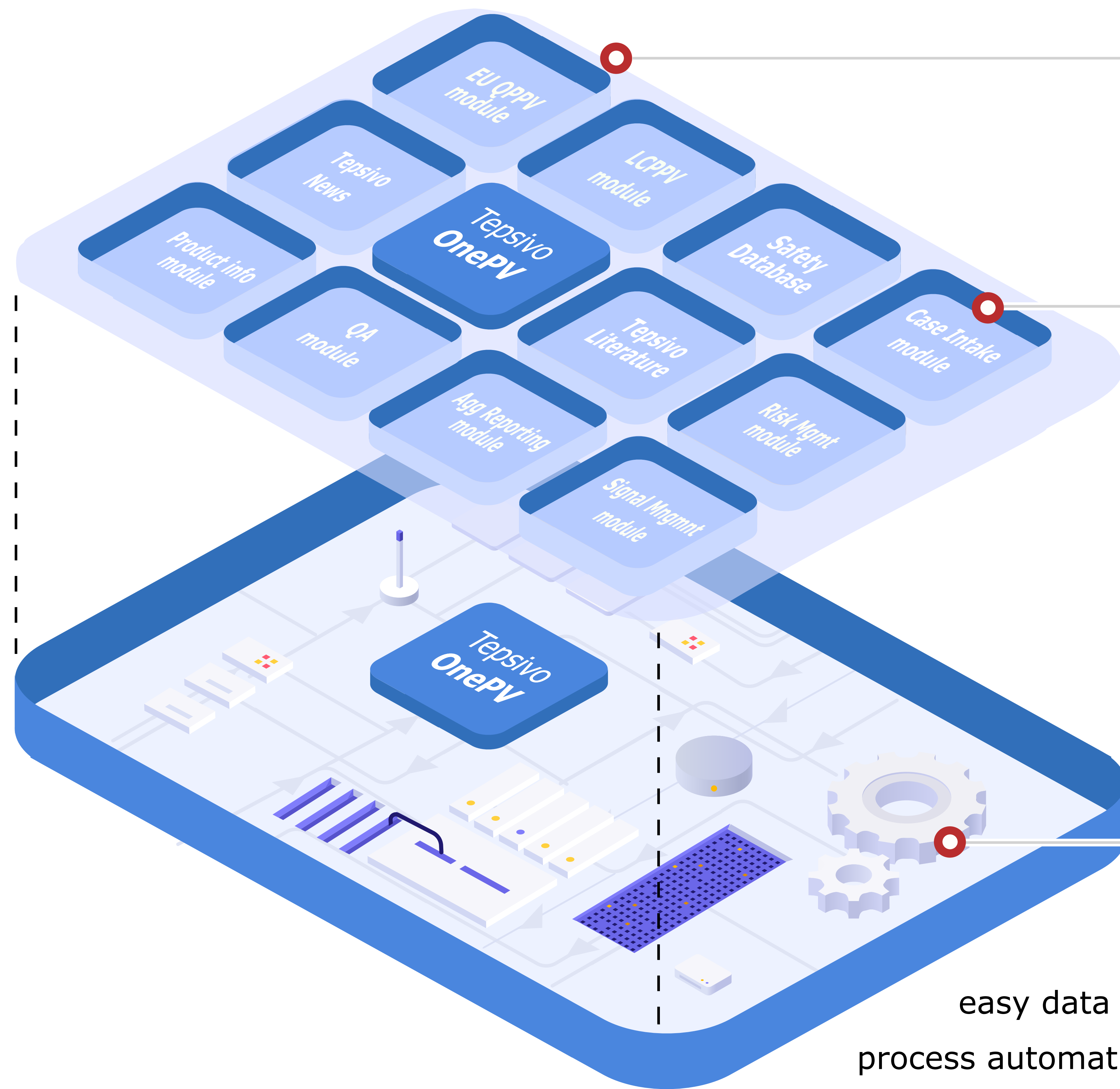
The benefits are clear: one vendor, no costly integration efforts, truly efficient workflows and an easy-to-use interface.

Cloud application storing & connecting data from all PV processes in one place

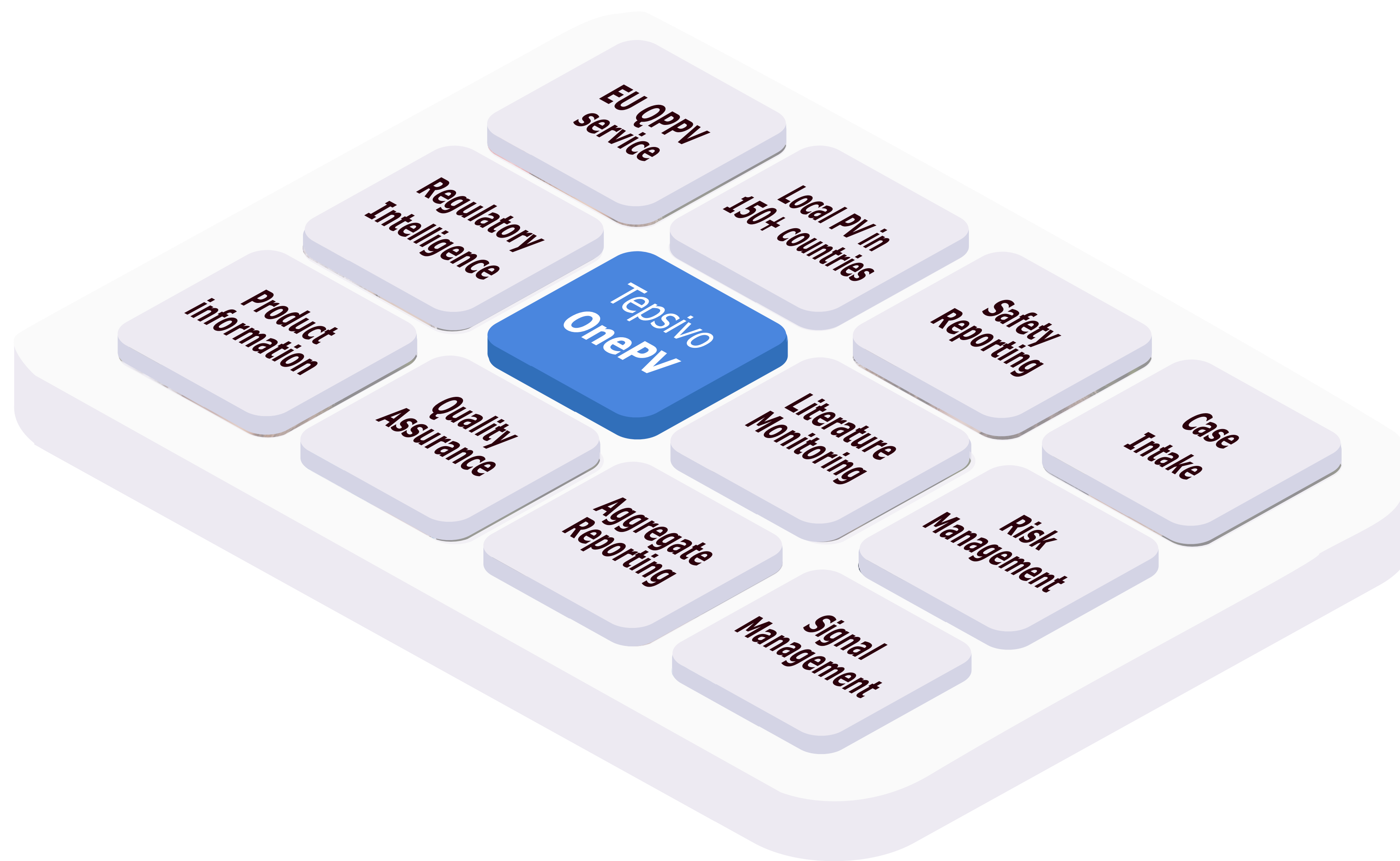
PV Process Modules

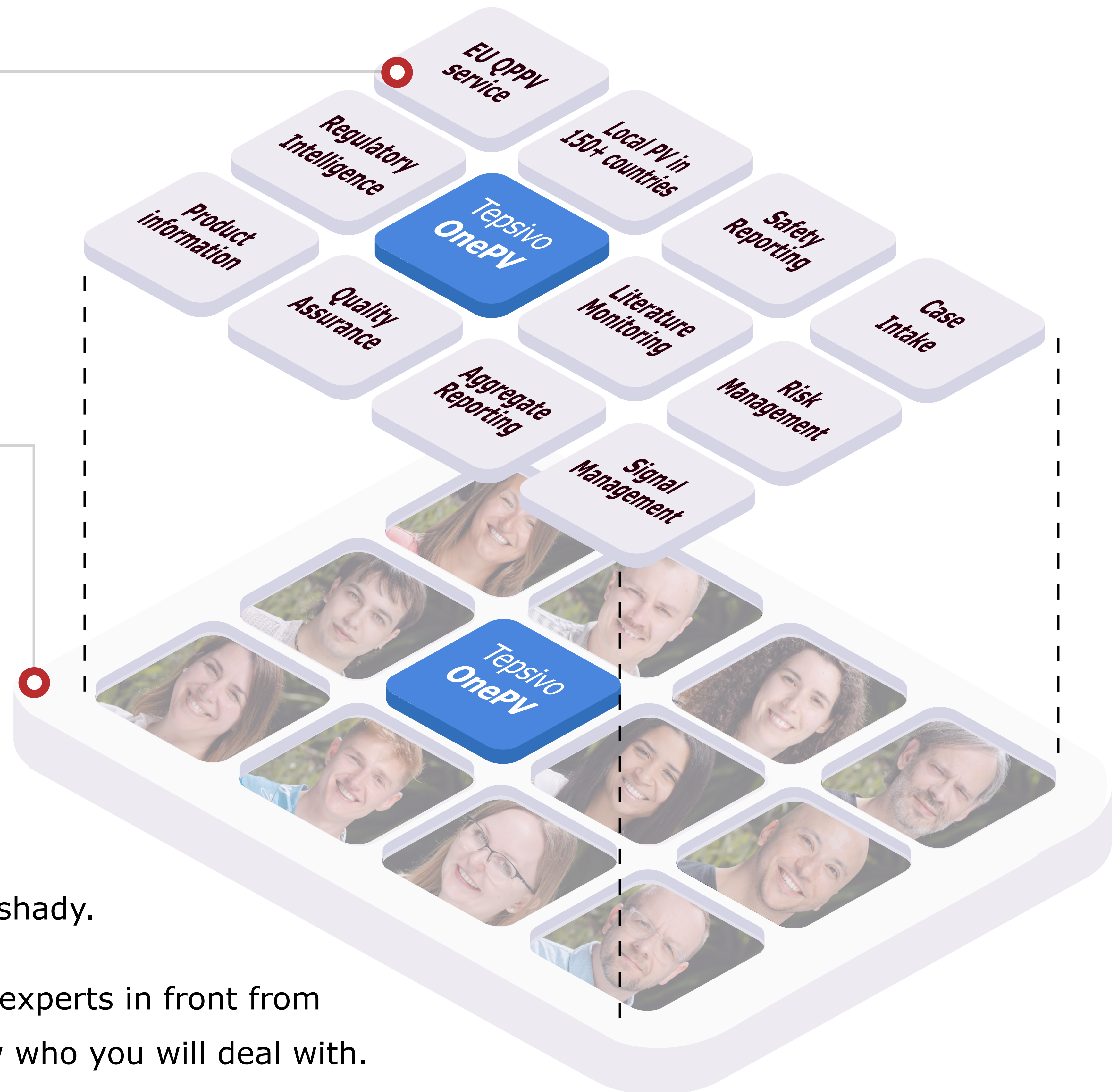

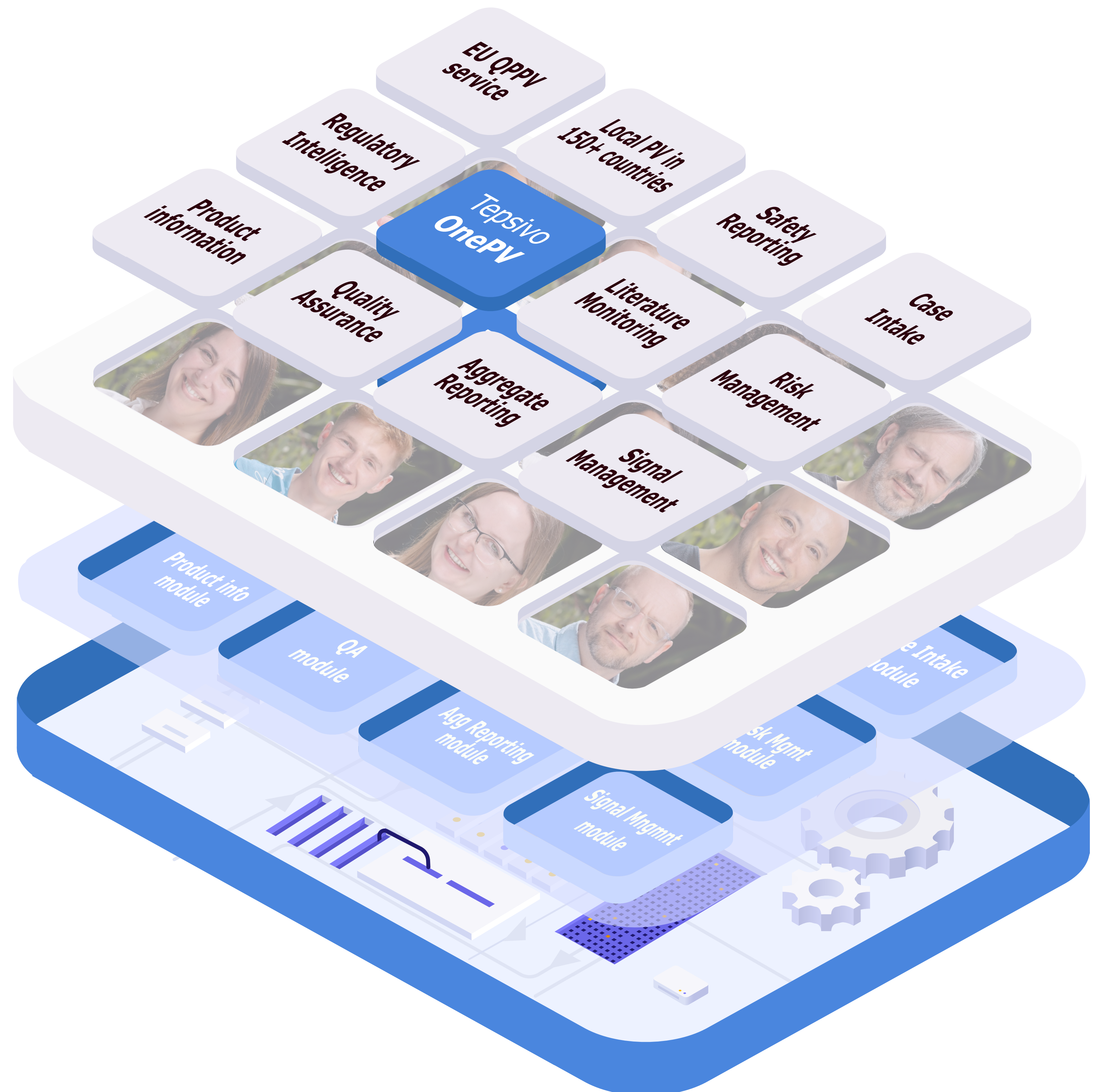

- Modern shifts in PV service delivery (flat-fee pricing, no ICSRs' limits...)

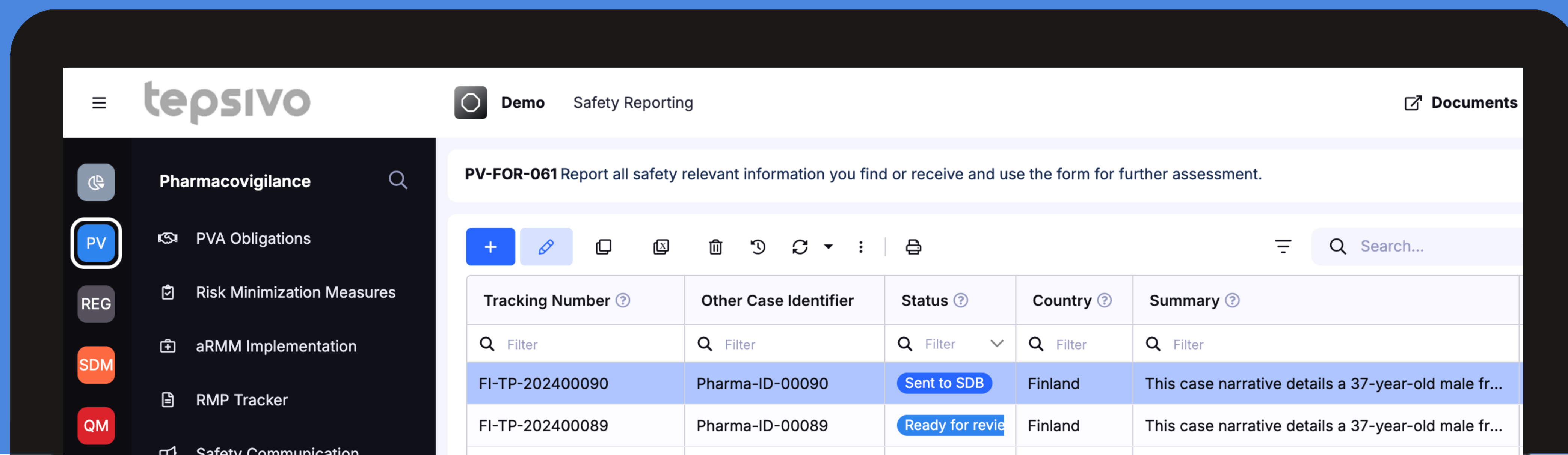
